

# The Visioning Committee is a voluntary group of church members given the responsibility to:

- Create a draft Vision Statement for presentation to the congregation
- Provide the congregation with a Mission Statement which, if completed, will achieve the Vision
- Develop a draft Strategic Plan
  - The short-term steps to support the mission, and the action components within the strategic plan
- ▶ The Visioning Committee is <u>NOT</u> a decisionmaking body



#### Our First Step: Identify the <u>Stakeholders</u>

What is a Vision Statement?

#### **Desired Future State**

- What we want to be when we are "done"
- A statement that is subject to change, but has a timeless core
- A statement that all must support to be successful
  - Not all need to agree, but all must support

#### **Proposed Vision Statement**

First Presbyterian Church of Richfield is a growing, giving family, relevant to the community, where all are welcome to come and worship God.

What is a Mission Statement?

- A description of what we will do to accomplish the Vision
  - · How we get to the desired future state
  - Support for the main elements of the Vision
    - People
    - Relevancy
    - Stability
- The mission statement is a three-legged stool that supports the Vision

#### **Proposed Mission Statement**

- We will continually grow the membership of First Presbyterian Church of Richfield.
- We will take responsibility for becoming more relevant to our community.
- We will explore more avenues to finance our outreach and stability.

## Next Steps

- Achieve congregational consensus on the Vision and Mission Statements
- Draft and propose a (1-year?) Strategic Plan that will be considered by the congregation
  - Development undertaken by the Visioning Committee upon agreement by the congregation
  - Document will contain the beginning Action Plans in our journey to complete the Vision
  - The Strategic Planning Process is aware of and subject to real-world constraints:
    - Manpower
    - Money
    - Time

## Action Plans Forming the Strategic Plan

#### All Action Plans Will Have **SMART** Goals

S = Specific - Crisp, Clear

M = Measurable - A number associated with the goal

**A = Attainable** - There is a good chance of getting it done

**R = Relevant** - Supports the Mission statement which supports the Vision

**T = Timely** - It can be done in the agreed upon timeframe
